# PARTNER COMMUNICATIONS ANNOUNCES THE SUPREME COURT DECISION TO PROHIBIT THE CONSTRUCTION OF CELLULAR RADIO ACCESS DEVICES THROUGH THE USE OF AN EXEMPTION FROM OBTAINING BUILDING PERMITS

Rosh Ha'ayin, Israel, September 16, 2010 - Partner Communications Company Ltd. ("Partner" or "the Company") (NASDAQ and TASE: PTNR), a leading Israeli communications operator, announced that the Supreme Court decided today, at the Attorney General's request, to issue a temporary injunction that prohibits the construction of cellular radio access devices through the use of an exemption from obtaining building permits. According to the Supreme Court decision, the temporary injunction will remain effective until the process of the enactment of regulations, which regulate the application of the exemption and which were submitted for the approval of the Economic Committee of the Parliament, is completed or until the Court decides otherwise.

In the Company's opinion, the inability to construct new cellular radio access devices through the use of the exemption set forth in the provisions of the law, may adversely affect the Company's ability to provide available and immediate telecommunication coverage in areas with reception difficulties and as result may adversely affect the service level to its customers.
