**Re: Immediate Report**

Today, December 25, 2011, the Board of Directors of the Company resolved to enter into an agreement with an international investment bank regarding the management, on behalf of the Company, of a process for the sale of a portion of its holdings in Partner Communications Company Ltd. ("**Partner**") to a strategic partner/partners, while maintaining the controlling interest by the Company, at a significantly higher price than Partner's market value. The goal of the sale is to strengthen the capital structure of the Company. The Board of Director's resolution also follows applications by various parties and following the demand of international funds for investment in telecom companies worldwide. The investment bank is expected to be selected in the near future and the Company will announce its decision accordingly.

The Company currently holds approximately 44.54% of the issued and outstanding shares of Partner of which approximately 16.6% are not pledged, and together with its controlling company, Suny Electronics Ltd., holds approximately 45.94% of the issued and outstanding shares of Partner.

The information contained in this immediate report includes forward looking information as defined in the Israeli Securities Law of 1968. There is no certainty that the Company will enter into an agreement with an investment bank or sell a portion of its holdings in Partner. Such actions are dependent on market conditions, offers to be received and its worthiness for the Company.
