(Immediate report according to regulation 36(A) of the Securities Regulations (Periodic and Immediate Reports)-1970)

Further to the Company's immediate report dated October 14, 2012 (reference number 2012-01-254238), and further to the Company's immediate report dated November 21, 2012 (reference number 2012-01-285408) with respect to the advanced negotiations towards a transaction between the Company and the Saban Group;

The Company announces that the said negotiations are at a very advanced stage and the Company estimates that an agreement between the parties regarding the transaction will be signed in the next few hours. In accordance with the layout of the transaction that has been formulated as of the time of this report, the Company will sell to the Saban Group most of its holdings in Partner Communications Company Ltd., and will enter with the Saban Group into a joint control of Partner, in consideration for payment in cash and for the endorsement to the Saban Group of the seller's loan, in the amount for USD 300 million, that Advent (from the Hutchison Group) granted to the Company for which the Company issued bonds (series E).

The Company wishes to emphasize that a binding agreement between the parties has not yet been signed, that there is no certainty that the said agreement will be signed and even if it is signed, its completion and execution are subject to various conditional terms.
