The details listed in this report, including the controlling shareholders of interested parties in the company, are as reported to the company from time to time by interested parties. The company is a company without a control core. This report on the status of interested parties and senior office holders' holdings is published following partial redemption of BONDS (Series 6, 7, and 8) as per the Israel Securities Authority's guidance and TASE's demand, requiring publication of such a report upon redemption of BONDS. Since the company does not have updated data on interested parties' holdings after September 30, 2025, this report reflects the data known for September 30, 2025, reduced by: (A) 24.97002390% of holdings in BONDS Series 6 resulting from partial redemption of Series 6 BONDS (8.33% of their original nominal value pursuant to the shelf offer report on November 29, 2016); (B) 16.363636299% of holdings in BONDS Series 7 resulting from partial redemption (9.00% of original value per shelf offer report on December 12, 2017); and (C) 14.3% of holdings in BONDS Series 8 resulting from partial redemption (14.3% of original value per shelf offer report on February 4, 2020). The company did not receive updated data from interested parties so further (unknown) changes may have occurred. Changes in senior office holders' holdings have been made due to exercising warrants after September 30, 2025, until the publication date.
