Update of Dividend Distribution Policy

1. BANK HAPOALIM B.M. ("the Bank") updates that, upon the management's recommendation, the Bank's Board of Directors approved on 12.8.2025 an update to the Bank's dividend distribution policy, which until now was to distribute up to 40% of the quarterly net profit derived from ordinary activities.

The updated dividend distribution policy is a distribution every quarter (with the possibility of a supplementary dividend in subsequent periods) at a rate of up to 50% of the net profit. This policy does not constitute an obligation by the Bank to distribute a dividend or regarding its rate, and any actual distribution will be subject to specific approval by the Board of Directors at its discretion, and subject to compliance with the provisions of the law and the conditions for making a distribution, including the provisions of the Companies Law and the directives and guidelines of the Bank of Israel. The actual dividend distribution rate may be affected by the extent of the Bank's share buybacks if and to the extent they are carried out in parallel.
