According to the agreements among the partners in the partnership, the ownership percentages change regularly, per the mechanism set in the partnership agreement. The holding percentages in the "Interested Parties - Investment Basket - Shekel Money" partnership as of 08.01.26 are: Pension and Provident (75.04%), Insurer - Participating in Profits (53.16%).
