Further to what is stated in Note 17(d)(8) to the Company's financial statements as of December 31, 2024, which were published on March 27, 2025 (reference no. 2025-01-021468), regarding the motion for approval of a class action filed with the Tel Aviv District Court against the Company, on the grounds of alleged damage caused to shareholders due to an error in the financial statements for the first quarter of 2023 (which was corrected in August 2023), the Company is honored to update that on March 2, 2026, the Court decided to grant the motion to approve the claim as a class action. In the Company's estimation, it holds good defenses in general and with respect to the amount of the motion in particular. In any event, the amount is not material for the Company.
