The company screened 11 candidates (4 females and 7 males), out of which 8 were interviewed (3 females and 5 males). The company's CEO interviewed the three final candidates (1 female and 2 males), and the appointed CFO (Mr. Zohar) was further interviewed by the Chairman of the Board and by the Chairperson of the Audit Committee.
