Following the immediate reports published by the company on November 11, 2025, December 30, 2025, December 31, 2025, and January 1, 2026 (Reference numbers: 2025-01-085722, 2025-01-104810, 2025-01-105404, and 2026-01-000427, respectively), regarding the agreement for the sale of the company's entire direct and indirect holdings (approximately 97%) in SBI International Holdings AG (a wholly owned subsidiary, held entirely through the company) in Reynolds Construction Company (Nigeria) Limited ("RCC"), to a contracting company in Nigeria, which is a third party unrelated to the company, the company wishes to update as follows:

As of the date of this report, SBI has received approximately USD 24.5 million out of the total consideration for RCC shares (approximately USD 42.3 million). The parties to the transaction continue to act to complete it, including the transfer of the remaining consideration for RCC shares (approximately USD 17.8 million) to SBI.
