Deletion of a Request for Approval of a Derivative Action for Removal of Oppression

Further to the company’s immediate report dated 16.1.2025 (Reference: 2025-01-004946) and section 4.3.2 of the update to the business description of the company included in the company's Q3 2025 report published on 11.11.2025 (Reference: 2025-01-086140), regarding the submission by a shareholder in the company (hereinafter: the "Representative Plaintiff") to the Economic Department at the Tel Aviv District Court, for approval of a derivative action on the grounds of oppression against the company (hereinafter: the "Request for Approval"), relating to a share buyback by the company from Manikay Fund conducted in January 2025, the company hereby updates as follows:

On 13.1.2026, the court issued a decision approving the representative plaintiff's request to withdraw (without compensation) from the request for approval (hereinafter: the "Withdrawal Request") and orders the dismissal of the request.

The Withdrawal Request stated that it was submitted following the court's comment during the preliminary hearing that, in the circumstances of the case, it finds it difficult to identify a basis for an oppression claim, and therefore suggested to the representative plaintiff to withdraw from the request for approval.

As a result, the representative plaintiff concluded that there is no substantial benefit in continuing the proceedings and furthermore asserted that since these matters relate to the class claim and not just his personal claim, there is no point in identifying an alternative applicant against the company.
