Teva to Acquire Théramex, Merck KGaA's European Based Women's Health Business

-- Acquisition Will Provide Teva with a Strong Platform to Expand its Global Women's Health Business --

Jerusalem, Israel, October 28, 2010 - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) and Merck Serono, a division of Merck KGaA (FRA: MRK) announced today that they have entered into a definitive agreement under which Teva will acquire Théramex and related companies from Merck Serono.

Théramex offers a wide variety of women's health products sold in 50 countries worldwide and had revenues of approximately €100 million in 2009, including sales in the countries in which Teva will acquire distribution rights. A significant portion of its revenues are derived from direct sales in France and Italy, where Théramex has developed strong brand recognition and a reputation for quality among women's health specialists. As part of the agreement, Teva will also have distribution rights for Théramex' products in certain countries including Spain and Brazil. The company's pipeline includes a new oral contraceptive based on natural estrogens, NOMAC/E2, which has successfully completed phase III studies and submitted for approval in Europe. Théramex's operations are supported by an accomplished R&D team and a cost-effective API facility, which produces most of the company's API needs.

Commenting on today's transaction, **Shlomo Yanai, Teva's President and Chief Executive Officer**, said: "This is an important acquisition for Teva's women's health franchise. Théramex's diversified product portfolio, its seasoned sales force and promising pipeline will be combined with the strong R&D capabilities and product portfolio of our U.S. women's health business. Together the global team will accelerate the expansion of our women's health franchise into key growth markets in Europe and around the world and provide an excellent springboard for future sales. We very much look forward to working together with Théramex's experienced management team and having its work force join the Teva family."

"Théramex has built a solid reputation in France and Italy as a company dedicated to women's health and gynecology. As Théramex is entering the contraceptive market, we firmly believe that a combination with Teva will not only contribute to growing its position in the gynecological market but also to building a major player in the area of contraceptives." said **Elmar Schnee, Member of the Executive Board of Merck KGaA and President of the Merck Serono division**.

Under the terms of the agreement, Teva will make a payment of €265 million at Closing. In addition, Merck Serono will be eligible to receive certain performance-based milestone payments. Teva will fund the acquisition from its internal resources. The transaction is subject to certain regulatory approval and is expected to close towards the end of this year or in early 2011.

טבע רוכשת את Théramex, חטיבת בריאות האישה של Merck KGaA באירופה

-- הרכישה תאפשר לטבע להרחיב משמעותית את פעילות תחום בריאות האישה של החברה ברחבי העולם --

טבע וחברת Merck Serono, חברת בת של Merck KGaA, הודיעו היום כי חתמו על הסכם לפיו טבע תרכוש מ-Merck Serono את חברת Théramex וחברות הקשורות אליה.

Théramex מציעה מגוון מוצרים בתחום בריאות האישה הנמכרים ב-50 מדינות ברחבי העולם, בהיקף של כ-100 מיליון אירו בשנת 2009, כולל מכירות במדינות שבהן טבע רכשה זכויות הפצה. חלק ניכר ממכירות החברה מגיע ממכירות ישירות בצרפת ואיטליה, שם Théramex היא מותג מוכר ומוערך על ידי מומחים לבריאות האישה. במסגרת ההסכם, תרכוש טבע גם את זכויות ההפצה למוצריה של Théramex במדינות מסוימות, כולל ספרד וברזיל. צבר המוצרים של החברה כולל אמצעי מניעה אוראלי חדש המבוסס על אסטרוגנים טבעיים, NOMAC/E2, שהשלים בהצלחה ניסויים קליניים בשלב III והוגש לקבלת אישור באירופה. פעילותה של Théramex נתמכת על ידי חטיבת מחקר ופיתוח מעולה ומפעל יעיל לייצור חומרים פעילים, המספק את רוב צרכי ה-API של החברה.

בהתייחסו לעסקה שנחתמה היום אמר **שלמה ינאי, נשיא ומנכ"ל טבע**, כי זוהי רכישה חשובה עבור חטיבת המוצרים לבריאות האישה של החברה. "מגוון המוצרים הרחב שמציעה Théramex, צוות המכירות המנוסה שלה וצבר המוצרים הנמצאים בפיתוח ישולבו עם יכולות המחקר והפיתוח וצבר המוצרים המבטיח של חטיבת בריאות האישה של טבע בארה"ב. שילוב שתי היחידות ליחידה גלובלית אחת תאיץ את התרחבותה של טבע בתחום זה ותאפשר לנו לחדור לשווקים מתפתחים מרכזיים באירופה ובעולם." ינאי הוסיף: "אנחנו שמחים לעבוד לצד ההנהלה המנוסה של Théramex ולצרף את עובדי החברה למשפחת טבע."

"Théramex בנתה לעצמה מוניטין בצרפת ואיטליה כחברה המקדישה את מרב מאמציה למוצרי בריאות האישה ומוצרים בתחום הגניקולוגיה. לאור שאיפת החברה להיכנס לשוק אמצעי המניעה, אנחנו מאמינים כי השילוב עם טבע יתרום לא רק לביסוס מעמד החברה בשוק הגניקולוגיה אלא גם להפיכתה לשחקן מרכזי בתחום אמצעי המניעה," אמר **אלמר שני, חבר דירקטוריון Merck KGaA ונשיא Merck Serono**.

במסגרת ההסכם תשלם טבע 265 מיליון אירו במועד סגירת העסקה. כמו כן, Merck Serono תהיה זכאית לקבל תשלומים נוספים מבוססי-תוצאה על פי אבני דרך שנקבעו מראש. טבע תממן את הרכישה באמצעות מקורותיה הפנימיים. סגירת העסקה תלויה באישורים רגולטוריים מסוימים. העסקה צפויה להיסגר לקראת סוף השנה או בתחילת 2011.
