Regarding section 1 above – The holdings of the controlling shareholders in the company are mainly through G.Y.N Financial Consulting and Investment Management 2017 Limited Partnership (Partnership No. 550272587) ("G.Y.N Partnership"). The partnership is under the full control and ownership of the controlling shareholders, who own it as limited partners through private companies fully owned by them, as well as hold the general partner in the G.Y.N Partnership. Regarding section 3B above – The holdings held under pension funds include direct holdings of the pension funds in the security (944,747 par value), holdings of the partnership "Beta Israel Shares Basket" (the "Partnership") totaling 0 par value, and holdings of the partnership "Harel Amittim Israeli Shares" (the "Partnership") totaling 1,881,667 par value. The partnerships are registered partnerships, and all rights holders in them are companies belonging to the institutional reporting group of the Harel Group. The partnerships themselves are not companies managing pension funds. According to the partnerships' agreements among the rights holders in the partnerships, the holding percentage of the rights holders in the partnerships is constantly changing according to the mechanism set in the partnerships' agreement. Below are the current holding rates in the partnership as of 23 October 2025:
