T7 GLOBAL DELIVERS RECORD HIGH QUARTERLY PAT IN Q3FYE2025

Kuala Lumpur, 25 November 2025 – Energy solutions provider, T7 Global Berhad (“T7 Global” or the “Group”, Bursa: 7228, Bloomberg: T7G:MK, Reuters: TGLO.KL) (T7 全球集团) today announced its financial results for the third quarter of its financial year ending 31 December 2025 (“Q3FYE2025”).

For the quarter under review, T7 Global delivered a strong set of results, registering revenue of RM216.1 million and profit before tax (“PBT”) of RM26.0 million, reflecting year-on-year (“Y-o-Y”) growth of 22.5% and 49.0% respectively. The Group’s profit after tax (“PAT”) surged 31.7% to RM18.7 million, marking the Group’s highest ever quarterly PAT.

For the cumulative nine months (“9MFYE2025”), the Group recorded revenue of RM528.2 million, representing a 15.1% Y-o-Y growth. The PBT and PAT grew by 12.2% and 21.8%, reaching RM46.1 million and RM35.8 million respectively. The energy segment remained the key revenue contributor, accounted for 77.0% of the total revenue and recorded a 59.1% Y-o-Y revenue growth.

T7 Global Group Chief Executive Officer Tan Kay Zhuin’s Statement: -

“We are pleased to deliver another resilient quarter, and the performance reflects the strength of our business and successful execution of key projects across both the energy and industrial solutions segments. Our long-term assets, particularly the mobile offshore production units (MOPUs), continue to provide stable and recurring income base, while the strong momentum from maintenance, construction and modification (MCM) and well & decommissioning contracts further reinforce our growth trajectory. Looking ahead, we remain focused on project



execution and will be more selective in pursuing for future works. Our commitment is to deliver sustainable returns and long-term value for our stakeholders.”
