ICI Pakistan Ltd. ('ICIP') has received intimation from its Substantial Shareholder i.e. Lucky Holdings Ltd. ('LHL') of a corporate restructuring under a Scheme of Arrangement pursuant to which LHL has reorganized in order to achieve cost efficiencies and a more tax efficient structure by demerging its assets and liabilities (as defined under the Scheme) to 5 newly constituted companies.

Pursuant to this arrangement, the 67,395,037 shares (72.97%) of ICIP held by LHL have been transferred to and stand vested in 5 newly constituted companies in the following manner:
