Business development, results of operations, financial position and net assets

Business Development

Revenue increased by 48.9% to &505.1 million in the reporting period (previous year: &339.1 million). The Group's profitability also improved significantly again compared to the previous year. EBITDA more than doubled from &49.7 million in the same period of the previous year to &105.8 million in the current financial year, resulting in an EBITDA margin of 20.9%. Adjusted EBIT increased significantly by 154.3% to &87.4 million (previous year: &34.4 million). The third quarter contributed to this excellent result in particular, after revenue and profitability had already increased significantly in the second quarter. In the third quarter, FRIEDRICH VORWERK generated revenue of &202.0 million (previous year: &145.0 million) and EBITDA of &551.3 million (previous year: &25.3 million), which corresponds to an EBITDA margin of 25.4% (previous year: 17.4%). This was due, on the one hand, to the continued success in personnel recruitment, which is reflected in employee growth of 13% (previous year: 14%) in the first nine months, on the other hand, to the continued high-quality order backlog of &1,101.5 million as of 30 September 2025 (31 December 2024: &1,187.7 million).

With regard to order intake, FRIEDRICH VORWERK has benefited from its excellent positioning in the rapidly growing market for energy infrastructure and, in addition to numerous small and medium-sized orders, has also acquired several major projects, most of which are being carried out in joint ventures. These mainly include the third section of the South German natural gas pipeline (SEL), an approximately 43 km long section of the SuedLink high-voltage direct current line, the Energy Transmission Line (ETL) 182 and ETL 179.200. The order intake of FRIEDRICH VORWERK amounted to €418.9 million in the first nine months (previous year: €516.4 million), which represents the Group's own contribution to the major projects carried out in joint ventures (ARGE) as well as the order volumes from own projects. The total project volume, including the proportionate ARGE order volumes, of the projects won in the first nine months increased by 45.5% to €885.7 million (same period of the previous year: €608.8 million).

On 27 February 2025, the FRIEDRICH VORWERK Group signed an agreement to acquire the Wischhafen branch, including the Stade site of Gerhard Rode Rohrleitungsbau GmbH & Co. KG, with effect from 1 April 2025. With around 40 employees, the branch is expected to generate annual revenue in the mid-single-digit million range. At the same time, the employees could already make a valuable contribution to the realisation of the Group's ongoing major projects from the second quarter of 2025.

On 18 March 2025, the German Bundestag approved a comprehensive debt-financed infrastructure investment budget in the order of €500 billion for the next 12 years. These investments could have a positive impact on FRIEDRICH VORWERK's business activities and further growth in the Adjacent Opportunities segment, among others. At the same time, the new government intends to leverage further potential to accelerate procedures in the planning and approval of infrastructure projects, which could have a positive impact on the planning and speed of realisation of complex construction projects in all of the Group's segments.

The Management Board and Supervisory Board of Friedrich Vorwerk Group SE proposed to the Annual General Meeting on 2 June 2025 to distribute a dividend of €0.30 per entitled share for the 2024 financial year and to carry forward the remaining amount to new account. The Annual General Meeting approved the company's proposal by a large majority. The dividend was paid out on 5 June 2025.

With effect from 1 August, the FRIEDRICH VORWERK Group took over the Brunn branch of Christoffers GmbH. With around 35 employees, the branch is expected to generate annual revenue in the low single-digit million range. At the same time, the takeover will significantly strengthen the Group's regional presence in Mecklenburg-Vorpommern.

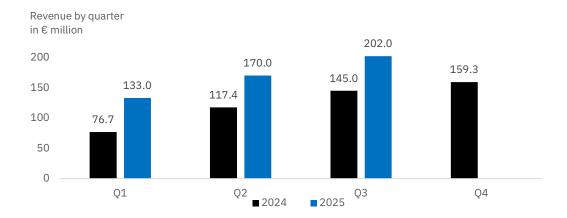
Results of operations, financial position and net assets

The key earnings figures include IFRS-related measurement effects and non-recurring expenses that are not used for corporate management purposes. In the financial year, these mainly included depreciation and amortisation on assets capitalised as part of purchase price allocations. Management therefore manages the Group on the basis of adjusted earnings figures, which reflect the operating profitability and development of the Group in a more transparent and sustainable manner.

At €1,101.5 million, the order backlog as at 30 September 2025 was slightly below the previous year's level (30 September 2024: €1,178.2 million). The order intake amounted to €418.9 million in the reporting period, which corresponds to a year-on-year decline of 18.9% (same period of the previous year: €516.4 million). The order intake trend is generally subject to a certain degree of volatility due to the nature of the business, as it can be influenced both positively and negatively by individual major projects. The order intake represents the Group's own contribution to the major projects carried out in joint ventures (ARGE) as well as the order volumes from own projects. Whereas, the total project volume, including the proportionate ARGE order volumes, of the projects won in the first nine months increased by 45% to €886 million (same period in the previous year: €609 million).

Of the order backlog, 16% is attributable to the Natural Gas segment, 67% to the Electricity segment, 3% to the Clean Hydrogen segment and 14% to the Adjacent Opportunities segment.

The consolidated revenue of the FRIEDRICH VORWERK Group amounted to €505.1 million in the reporting period. This corresponds to an increase of 48.9% compared to the same period of the previous year (€339.1 million). The main driver of revenue growth in the first nine months is the major A-Nord project, which contributed around 35% of Group revenue in the reporting period. Another growth driver is the continued success in recruiting. The number of employees increased by 13.3% compared to 31 December 2024 to 2,208 employees.



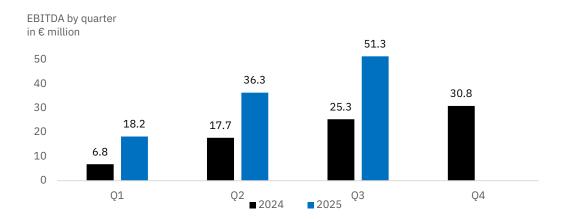
Income from equity investments increased by €2.9 million year-on-year to €11.5 million (previous year: €8.6 million) due to a higher proportion of projects carried out in joint ventures (ARGE). Other operating income increased slightly to €4.9 million (previous year: €3.8 million).

The cost of materials increased at a slightly lower rate than revenue by 41.3% to €230.6 million (previous year: €163.1 million). The cost of materials ratio of 45.7% is therefore lower than the previous year's cost of materials ratio (previous year: 48.1%).

Personnel expenses of €136.0 million increased by 23.9% compared to the previous year (previous year: €109.8 million). The increase is mainly due to wage and salary increases as well as an increase in the average number of employees. Compared to the same period last year, the average number of employees in the first nine months rose by 15.0%.

Overheads rose by 70.8% to €49.2 million in the reporting period (previous year: €28.8 million). The increase is mainly due to the costs for the short-term rental of equipment and other construction site facilities, which are required for the parallel realisation of numerous major projects.

EBITDA (earnings before interest, taxes, depreciation and amortisation) increased by €56.0 million to €105.8 million in the reporting period (previous year: €49.7 million). On the one hand, the continued success in personnel recruitment and, on the other, the very high-quality order backlog contributed to this. The EBITDA margin is 20.9% (previous year: 14.7%).



After adjusted depreciation and amortisation of &18.4 million (previous year: &15.4 million), adjusted EBIT amounted to &87.4 million (previous year: &34.4 million). The year-on-year increase in depreciation and amortisation is mainly the result of increased investment activity in previous years. Adjusted consolidated net income after minority interests amounted to &57.3 million (previous year: &22.3 million) or &2.87 per share (previous year: &1.12 per share).

Equity amounted to &255.7 million as of 30 September 2025 (31 December 2024: &205.0 million). The increase in equity is due to the current annual result. The payment of a dividend of &6.0 million, which was approved by the Annual General Meeting on 2 June 2025, had the opposite effect. In relation to the consolidated balance sheet total of &466.2 million (31 December 2024: &437.6 million), the equity ratio was 54.8% as of the balance sheet date, compared to 46.9% as of 31 December 2024.

As of 30 September 2025, the FRIEDRICH VORWERK Group had liquidity reserves (including securities) of €130.4 million (31 December 2024: €176.6 million). The decline in liquidity reserves is mainly due to payments for investments amounting to €35.9 million and the increase in working capital of €89.7 million. After deducting financial liabilities of €19.0 million (31 December 2024: €22.4 million), net cash and cash equivalents amounted to €111.4 million (31 December 2024: €154.3 million).

The change in cash and cash equivalents in the reporting period amounted to €-50.8 million (previous year: €-4.5 million) and is made up as follows:

The net cash inflow from operating activities amounted to €2.4 million (previous year: €21.7 million). The operating cash flow is generally characterised by a seasonal increase in net working capital in the first three quarters, which then reverses in the fourth quarter. A significantly higher cash flow from operating activities is expected for the year as a whole.

Cash flow from investing activities amounted to €-41.9 million (previous year: €-27.7 million) and mainly relates to investments in technical equipment and machinery, the expansion and extension of the Group's locations, payments for the acquisition of the Wischhafen and Brunn branches and investments in securities.

Cash flow from financing activities amounted to €-11.3 million (previous year: €1.5 million) and mainly consists of the dividend payment of €6.0 million and ongoing interest and principal payments.

Outlook

Against the backdrop of the excellent development and an unchanged positive outlook, the Management Board of Friedrich Vorwerk Group SE raised its forecast for the 2025 financial year for the second time on 21 October 2025 and now expects revenue of ϵ 650-680 million after previously forecasting revenue of ϵ 610-650 million. In addition, the Management Board has increased the forecast of EBITDA margin to 20.0-22.0%, which was previously expected to be in the range of 17.5-18.5%.
