### Clarification of News Item Pertaining to Removal of Cap on Dividend Payment by MPCL

Reference the news item published in different newspapers which states that during a meeting of the Cabinet Committee on Privatisation, chaired by the Prime Minister Imran Khan, the issue of de-capping of MPCL dividend to expedite its divestment process was discussed. The news item further states that the privatisation commission and petroleum division have agreed to take this issue to the Economic Coordination Committee, as the dividend cap was originally imposed by ECC.
