	Observations /Remarks of the Practicing Company Secretary	During the course of our examination, we observed that the Company was required to file voting results (XBRL) within the period provided under Regulation 44(3) of SEBI (LODR), 2015 for AGM held on 24/09/2025 but due to certain technical issues in uploading, not filed the same within due time. Hence, advised to the management to take due care in future and comply the regulations within the stipulated time limit.
	Management Response	The delay was purely unintentional and caused due to technical reasons beyond the company's control. The company will ensure timely submission of XBRL filings in future. This matter was subsequently acknowledged by BSE, which raised a query via email dated 14th October 2025 and no further adverse action has been taken in this regard. This delay was completely inadvertent.
	Remarks	Advised to the management to take due care in future and comply the regulations within the stipulated time limit.
