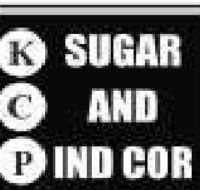

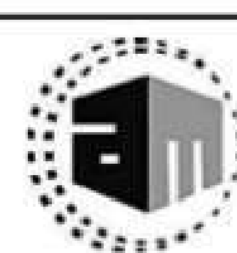

या पाहणी दरम्यान रुग्णालयात नवीन बेडशीट आणि गाऊनचे गट्टेच्या गट्टे गोदामात उपलब्ध असतानाही, आयसीयू (ICU) सारख्या अत्यंत संवेदनशील विभागात रुग्णांना साधो चांदर किंवा बेडशीट दिली जात नसल्याचे समोर आले. येथील कर्मचाऱ्यांकडून रुग्णांना थेट घरून बेडशीट आणि गाऊन आणायला लावले जाते, ही अत्यंत गंभीर आणि चुकीची बाब असल्याचे मनोज पाटील यांनी सांगितले. आयसीयूमध्ये रुग्णांची विशेष काळजी घेणे आणि जंतुसंसर्ग टाळण्यासाठी निर्जंतुक कपडे वापरणे आवश्यक असताना, रुग्णांना अशा प्रकारे घरून कपडे आणायला सांगणे किंवापत योग्य आहे, असा सवाल त्यांनी उपस्थित केला.

या हून ही धक्कादायक बाब म्हणजे, कोरोना काळात नागरिकांच्या पैशातून खरेदी करण्यात आलेली विविध माध्यमांतून मिळालेली कोट्यवधी रुपयांची वैद्यकीय उपकरणे या ठिकाणी धूळ खात पडली आहेत. यामध्ये जवळपास ९ लाख ६ हजार रुपये किमतीचे १०० हून अधिक ऑक्सिजन कॉन्स्ट्रेटर आणि प्रत्येकी ८० हजार रुपये किमतीची



ऑक्सिजनशी संबंधित इतर १५० हून अधिक मशीनरी (सी-पॅप) यांचा समावेश आहे. जवळपास २ कोटी रुपयांचे हे साहित्य आणि अनेक चांगले बेड येथे विनावापर पडून सडत आहेत. दुसरीकडे, दोन दिवसांपूर्वीच येथील डीएम पेटीट रुग्णालयात प्रसूतीसाठी आलेल्या एका १०० किलो वजनाच्या महिलेचा पलंग तुटल्याची दुर्घटना घडली होती. एकीकडे नवीन उपकरणे धूळ खात आहेत आणि दुसरीकडे रुग्णांना चुन्या व नादुरुस्त साहित्याचा सामना करावा लागत आहे, यावरून पालिकेचा नियोजनशून्य कारभार स्पष्ट होतो.
