Other comments:

Custos Vermögensverwaltungs GmbH and Salapo Beteiligungsverwaltungs GmbH established a merger contract on March 4, 2021, that transfers the assets of Salapo Beteiligungsverwaltungs GmbH. Salapo Beteiligungsverwaltungs GmbH's principle asset comprises 5.72% of the shares in ANDRITZ AG, held indirectly through its holding in Certus Beteiligungs-GmbH. When the merger is registered, Custos Vermögensverwaltungs GmbH will hold an additional 5.72% of the shares directly in addition to its current direct holding of 25%, thus bringing its total shareholding in ANDRITZ AG to 30.72%.
