Announcement of intention to launch a EUR 400 million voluntary partial tender offer

The Managing Board has, subject to the approval of the Supervisory Board, set a volume of EUR 400 million and an offer price of EUR 36.84 per share, which corresponds to the closing price of yesterday, 17 October 2019. Shares acquired in the course of the Offer will be canceled.

The final terms and further provisions in relation to the Offer will, subject to the review of the Austrian Takeover Commission, be published in the offer memorandum. The Company reserves the right to deviate from the terms presented herein. The offer memorandum is expected to be published until end of October 2019.
