AZEUS AWARDED TENDER TO SUPPLY IT SERVICES TO THE HONG KONG GOVERNMENT FOR FIFTH CONSECUTIVE TERM

- ***Prequalifies Azeus as an approved tenderer for complex government IT projects, worth up to HK\$15 million***
- ***Testament to Azeus' established public sector track record***

Singapore, 21 July 2017 – Azeus Systems Holdings Ltd (“**Azeus**” or the “**Group**”) today announced that it has been awarded the Standing Offer Agreement for Quality Professional Services 4 (“**SOA-QPS4**”) for Service Categories 1, 2 and 3, which will allow the Group to tender for various government IT professional services contracts, including IT project management and system development services, of up to HK\$15 million.

Azeus is one of the 49 companies that was awarded the SOA-QPS4. The latest agreement will take effect from 31 July 2017 and last for a period of 48 months. The SOA-QPS4 is a replacement for the Standing Offer Agreement for Quality Professional Services 3 (“**SOA-QPS3**”), which expired in July 2017.

Mr. Lee Wan Lik, Managing Director of Azeus, said, “We are pleased to be chosen as one of the approved tenderers for complex government IT projects by the Hong Kong Government for the fifth consecutive term. This is a clear recognition of the quality of Azeus’ IT solutions and service delivery by the public sector. SOA-QPS4, coupled with our established private sector track record, will enable us to better encapsulate both public and private sector markets in our continued pursuit of growing the business.”
