The weighted average price is 0.92 Baht per share with 90% of the weighted average price equal to 0.8280 baht per share, then the conversion price is 0.8280 Baht per share which is not less than 90.00 percent weighted average price. The balance of convertible debentures no. 10/2021 which are not exercised at the amount of 5.0 million Baht (5,000 units) on October 15, 2021, the convertible debenture holders have exercised their conversion rights at the amount of 5.0 million Baht (5,000 units). As a result, there are no convertible debentures No. 10/2021 that have not been exercised.
