The Debenture Holders' Meeting No. 1/2022 ("the Meeting") of "Debenture of Cho Thavee Public Company Limited No. 1/2021, due 2022 Callable bond" ("Debenture" or "CHO228A") on Monday, July 25, 2022 via E-Meeting by live broadcasting from the meeting room on the 3rd floor, the office of the Company Branch 1, No. 96/25 Vibhavadi Rangsit Road, Talat Bang Khen Subdistrict, Lak Si District, Bangkok. There were 69 debenture holders and proxy holders present at the Meeting, holding aggregate totally 84,500 units which equivalent 83.09 percent of the total debentures which constituted a quorum in accordance with the Terms and Conditions governing the rights and obligations of the issuer and debenture holders, so the Meeting began o 10.00 a.m. There were 1 debenture holder who hold totaling 1,000 shares present and join the vote after the Meeting start.]

The Meeting has passed with the following resolutions:

1. Approved the extension of CHO228A's maturity date for 1 year and revision of the redemption date from 29 August 2022 to 29 August 2023 and approved to change the name of the debentures to be in line with the amendment of the maturity date.
