The balance of convertible debentures which are not exercised at the amount of 10.00 million Baht (10,000 units). November 3, 2022, the convertible debenture holders have exercised their conversion rights at the amount of 1.25 million Baht (1,250 units). As a result, there are the convertible debentures that have not been exercised at the amount of 8.75 million Baht (8,750 units).
