The balance of convertible debentures which are not exercised at the amount of 8.75 million Baht (8,750 units). November 30, 2022, the convertible debenture holders have exercised their conversion rights at the amount of 2.50 million Baht (2,500 units). As a result, there are the convertible debentures that have not been exercised amount of 6.25 million Baht (6,250 units).
