Rosenbauer International AG (ISIN AT0000922554) received an announcement in accordance with §91 BörseG (Austrian Stock Exchange Act), that from June 7, 2016 on, Objectif Small Caps Euro Sicav (Sicav) is authorized to exercise a total of 344.205 voting rights (or 5.06%) attached to the shares in Rosenbauer International AG, thereby crossing above the 5% voting rights threshold.

This notification has to be read in conjunction with the notification of Lazard Frères Gestion (Lazard) from today. Therefore Lazard is now authorized to exercise directly and indirectly through Sicav 5.10% voting rights attached to the shares in Rosenbauer International AG.
