Rosenbauer International AG (ISIN AT0000922554) received an announcement in accordance with §91 BörseG (Austrian Stock Exchange Act), that from June 7, 2016 on, Lazard Frères Gestion SAS (Lazard) is authorized to exercise a total of 346,805 voting rights (or 5.10%) attached to the shares in Rosenbauer International AG, thereby crossing above the 5% voting rights threshold.

Therefore Lazard is now authorized to exercise directly, and indirectly through Objetif Small Caps Euro Sicav (Sicav), 5.10% voting rights attached to the Shares in Rosenbauer International AG. This notification has to be read in conjunction with the notification of Sicav (fond of Lazard), from today. Sicav is authorized to exercise directly 344,205 voting rights (or 5.06%) attached to the shares in Rosenbauer International AG.

2,000 voting rights (or 0.04%) are owned by Lazard on behalf of "Investissement PEA-PME FCB".

The total number of shares and voting rights in Rosenbauer International AG is 6,800,000.
