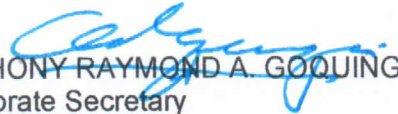

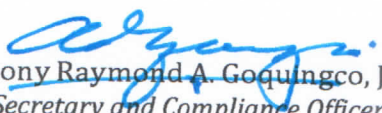
Gentlemen:

The University posted a consolidated net income of Php 2.09 billion for the period ended 31 May 2025, up 3.9% in the same period last year.
