The numbers notified above do not include the voting rights from 146,197 shares and from 75,000 long call options held by UI Petrus Advisers Special Situations Fund as of 07 October 2024. Klaus Umek / Petrus Advisers Ltd. can only issue recommendations on the exercise of the voting rights concerned but cannot otherwise exercise any further influence. Therefore, these voting rights are not to be attributed to Klaus Umek / Petrus Advisers for the purpose of this notification but are merely disclosed in this Section 10 of this notification for full transparency only.

The 252,965 voting rights from shares notified under section 7.A (indirect) include 201,615 voting rights that are attributable to Petrus Advisers Ltd. based on voting proxies granted by natural persons and are therefore not reflected under section 8.
