- A proxy need not be a shareholder of the Company. - 2 The appointment of the Chairman of the meeting as proxy has been included for convenience. To appoint any other person as proxy, delete the words "the Chairman of the meeting" and insert the name of the person appointed proxy in the space provided. If the proxy is being appointed in relation to only part of your shareholding, please enter in the box next to the proxy's name the number of shares in relation to which he is authorised to act as your proxy. If this box is left blank, he will be authorised in respect of your entire shareholding.
