



## 5th Planet Games A/S Announces Physical Distribution Agreement with BIGBEN Interactive S.A.

Deathtrap, Before Your Eyes* and *Goodnight Universe* to market in these regions, with similar plans for upcoming titles including the highly anticipated fighting game *Invincible VS*.

"Whilst the global video games market continues its migration towards digital delivery, there remains a significant market for physical boxed product. In some cases, this can represent almost half of the lifetime sales of a game, as well as the opportunity for additional related SKUs including premium Collector's Editions and other associated merchandise. Our new partnership with BIGBEN Interactive, a company that has been working in this space for decades, now extends 5th Planet's capabilities in delivering and marketing physical games to customers across much of Central and Northern Europe."
