

## Capital increase in TORM due to exercise of Restricted Share Units as part of TORM's incentive program

TORM plc ("TORM") increases its share capital by 10,634 A-shares (corresponding to a nominal value of USD 106.34) as a result of the exercise of a corresponding number of Restricted Share Units. Subsequent to such share capital increase further 170,133 RSUs are eligible for exercise during 2023.

The capital increase is carried out without any pre-emption rights for existing shareholders or others. All 10,634 new shares are subscribed for in cash. All 10,634 of the new shares have been subscribed for at DKK 31.0 per A-share.

The new shares are ordinary shares without any special rights and are negotiable instruments. The new shares give rights to dividends and other rights in relation to TORM as of the date of issuance. The new shares are expected to be admitted to trading and official listing on Nasdaq in Copenhagen on 12 April 2023. Transfer restrictions may apply in certain jurisdictions outside Denmark, including applicable US securities laws.

After the capital increase, TORM's share capital amounts to USD 832,787.37 divided into 83,278,735 A-shares of USD 0.01 each, one B-share of USD 0.01 and one C-share of USD 0.01. A total of 83,278,735 votes are attached to the A-shares. The B-share and the C-share have specific voting rights.
