

MINUTES OF THE EXTRAORDINARY SHAREHOLDERS' GENERAL ASSEMBLY MEETING OF THE QNB BANK ANONIM SIRKETI, HELD ON AUGUST 19, 2025

The Extraordinary Shareholders' General Assembly of the QNB Bank Anonim Sirketi was held under the supervision of Ms. Sabire Demir Elbükten who was commissioned by the letter No. E-90726394-431.03-00112505322, dated 15.08.2025, of the Provincial Directorate of Istanbul affiliated to the Ministry of Trade of the Republic of Turkey at the Bank's Head Office, which locates at Esentepe Mahallesi, Buyukdere Caddesi, Kristal Kule Binasi, No: 215, Sisli-Istanbul, at 11:00 am on Tuesday, August 19, 2025.

It was ascertained that the convocations for and the notice of the meeting, which included the meeting agenda was announced, as stipulated by the Law and by the Articles of Association, by way of publications of the same within the issue No. 11378, dated July 25, 2025 of the Trade Registry Gazette of Turkey, on the Bank's official website at www.qnb.com.tr, through the Public Disclosure Platform, Electronic General Assembly System, and also within Dünya daily newspaper.

It was ascertained that Mr. Temel Guzeloglu and Saleh Nofal, Board Members of the Bank and Mr. Osman Ömür Tan, the General Manager and member of the Board of Directors, were present and ready at the meeting venue. It was ascertained through the review of the list of attendants that the shares, corresponding to TRY 3.345.892.247,466 share capital, out of 33,500,000,000 shares, corresponding to TRY- 3.350.000.000 total share capital of the company, were represented by proxy, while the shares, corresponding to TRY- 35.479 share capital, were represented in principal, through the agency of the attorneys of the relevant principal shareholders, and thus, the shares corresponding to TRY 3.345.927.726,466 share capital were duly represented at the meeting, and that, therefore, the minimum quorum requirement for meeting pursuant to both the Law and the Articles of Association had been satisfied, whereupon the meeting was opened. The Shareholders' Meeting was also commenced concurrently in the electronic medium pursuant to the provisions of Article 1527 of the Turkish Commercial Code. It was ascertained that any attorney of any principal shareholder was not present among the persons, who physically attended the meeting. The agenda was discussed.

1- The motion regarding the first item of the meeting agenda was read. The meeting participants were asked whether or not any meeting participant would like to take the floor, whereupon it was established that any meeting participant would not like to do so.

According to the motion, which was put to vote; it was unanimously approved by the votes to elect and appoint Mr. Adnan Menderes Yayla as the Chairperson of the Meeting Council, to elect and appoint Mr. Ercan Sakarya as the Vote Collector, and to elect and appoint Mr. Ali Yılmaz as the Secretary during the meeting; and authorize Meeting Council Presidency to sign the minutes of the Extraordinary Shareholders' General Assembly.

2- The motion regarding the second item of the meeting agenda was read. The meeting participants were asked whether or not any meeting participant would like to take the floor, whereupon it was established that any meeting participant would not like to do so.

The motion for the assumption that; within the scope of the Banking Regulation and Supervision Agency approval dated June 20, 2025 and numbered 157914 and the Capital Markets Board's approval dated July 17,2025 and numbered 40/1243; in accordance with the provisions of the Banking Law numbered 5411 and "the Regulation on Merger, Transfer, Spin-off and Share Exchange of Banks, and the Communiqué on Merger" published in the Official Gazette dated 01.11.2006 and Demerger numbered II-23.2, we offer and propose to approve transfer "enpara.com" banking services of QNB Bank A.Ş. to Enpara Bank A.Ş. through partial spin-off, the signed partial Spin-off Agreement dated April 24, 2025 and its annexes, along with the balance sheet and profit and loss statement were read since it had been published through the Public Disclosure Platform, the Electronic Shareholders' Assembly System and the Bank's website and for the voting on the matter to be held was read, following which the attendees were asked whether or not any attended would like to take the floor, whereupon it was established that any attendee would not like to do so; the motion was unanimously approved.

In accordance with the motion made; within the scope of the Banking Regulation and Supervision Agency approval dated June 20, 2025 and numbered 157914 and the Capital Markets Board's approval dated July 17,2025 and numbered 40/1243; in accordance with the provisions of the Banking Law numbered 5411 and "the Regulation on Merger, Transfer, Spin-off and Share Exchange of Banks, and the Communiqué on Merger" published in the Official Gazette dated 01.11.2006 and Demerger numbered II-23.2, the matters of approval of transfer "enpara.com" banking services of QNB Bank A.Ş. to Enpara Bank A.Ş. through partial spin-off, the signed partial Spin-off agreement dated April 24, 2025 and its annexes, along with the balance sheet and profit and loss statement

and authorization of the Head Office to execute necessary transactions related to partial division were unanimously approved.

3- The wishes and expectations were stated by the meeting participants.

In this context, in response to questions from shareholders regarding when QNB Bank A.Ş. shares which are temporarily suspended would be traded, the Chairperson of the Meeting stated that QNB Bank A.Ş. shares would be traded once the necessary official procedures are completed, following the registration of Enpara Bank A.Ş. shares at the Central Registry Agency (CRA) and the subsequent distribution of the Enpara Bank shares to the rightful QNB Bank shareholders. In response to the question regarding when Enpara Bank A.Ş. shares will be traded, the Chairperson of the Meeting stated that Enpara Bank A.Ş. shares will be traded following the registration of Enpara Bank A.Ş. shares and the obtaining of the necessary approvals from the relevant regulatory bodies, including the Banking Regulation and Supervision Agency (BRSA) and the Capital Markets Board (CMB)

In response to a question from our shareholders regarding whether a reference price and free margin will be applied to QNB Bank A.Ş. and Enpara Bank A.Ş. shares, the Chairperson of the Meeting stated that this matter will be evaluated and determined by Borsa Istanbul.

The Chairperson of the Meeting provided detailed information in response to questions from our shareholders regarding the number and percentage of shares they will hold in Enpara Bank A.Ş. and the process steps to be followed in the forthcoming period.

The Chairperson of the Meeting provided information to our shareholders in response to their questions on ongoing bonus issue process of QNB Bank A.Ş. and whether this bonus issue process would affect the number of shares to be held in Enpara Bank A.Ş. In addition, opinions were conveyed regarding the increase in the ratio of shares in free float.

The Chairperson of the Meeting provided information in response to the questions submitted by our shareholders through the Electronic General Assembly System regarding whether or not the Bank considers to be delisted from the pre-market trading platform, or use extraordinary reserve funds.

Given the fact that, there were no further meeting agenda items left to be discussed and resolved, the Chairperson and shareholders respectfully greeted the meeting participants, and the meeting was adjourned, also on the Electronic General Assembly System, at 11:39 am.

PARTIAL SPIN-OFF AGREEMENT

1- PARTIES

Between,

- (i) **QNB BANK ANONİM ŞİRKETİ**, which is registered with the Istanbul Trade Registry Directorate with the registration number 237525-0, registered with the Istanbul Large Taxpayers Tax Office Directorate with the tax number 3880023334, registered with the MERSIS number 0388002333400576 and has its registered address at Esentepe Mah. Büyükdere Cad. Kristal Kule Binası No:215 Şişli/İstanbul (the “**Spin-off Company**” or “**QNB Bank**”)

and

- (ii) **ENPARA BANK ANONİM ŞİRKETİ**, which is registered with the Istanbul Trade Registry Directorate with the registration number 494129-5, registered with the Istanbul Large Taxpayers Tax Office Directorate with the tax number 3350917589, registered with the MERSIS number 0335091758900001 and has its registered address at Esentepe Mah. Büyükdere Cad. No: 215 Şişli/İstanbul (the “**Acquiring Company**” or “**Enpara Bank**”)

this **PARTIAL SPIN-OFF AGREEMENT** (hereinafter referred to as the “**Partial Spin-off Agreement**” or the “**Agreement**”) which consists of fourteen (14) articles and sets forth the terms and conditions of the partial spin-off to be implemented.

2- DEFINITIONS

The Spin-off Company and the Acquiring Company shall be hereinafter referred to as the “**Parties**”.

In this Agreement;

“**Banking Law**” refers to the Banking Law numbered 5411,

“**BRSA**” refers to the Banking Regulation and Supervision Agency,

“**Corporate Tax Law**” refers to the Corporate Tax Law numbered 5520,

“**MKK**” refers to Central Registry Agency (Merkezi Kayıt Kuruluşu A.Ş.),

“**CMB**” refers to the Capital Markets Board of Türkiye,

“**Capital Markets Law**” refers to the Capital Markets Law numbered 6362,

“**Communiqué**” refers to the Communiqué on Merger and Demerger numbered II-23.2,

“**TCC**” refers to the Turkish Commercial Code numbered 6102.

“**Regulation**” refers to the BRSA Regulation on Merger, Transfer, Demerger and Share Exchange of Banks,

3- SUBJECT AND METHOD OF SPIN-OFF

The application submitted pursuant to Article 5 of the Regulation regarding the initiation of the partial spin-off process has been approved by the BRSA pursuant to its letter dated 10 February 2025 and numbered E-32521522-101.01.03[31]-144557.

At the Extraordinary General Assembly of QNB Bank held on March 17, 2025 and at the Ordinary General Assembly of Enpara Bank held on March 18, 2025, the Boards of Directors of the Parties have been authorized to initiate the necessary legal proceedings for the transfer of the Enpara.com service business operating within QNB Bank to Enpara Bank through partial spin-off with its assets and liabilities included in the annex of this Agreement (Annex-1) and at book value.

Pursuant to the foregoing, the application made within the scope of Article 17 of the aforementioned Regulation was authorized by the BRSA with the letter dated _____ and _____. The Announcement Text prepared for the partial spin-off transaction has been approved by the CMB with the date _____ and number _____.

(Note: The blanks in this paragraph will be filled before the General Assembly approvals are obtained in accordance with Article 17(3) of the Regulation)

The partial spin-off transaction shall be completed upon the adoption of the General Assembly resolutions of the Parties referred to the above and the General Assembly Resolutions to be adopted in accordance with Article 17 of the Regulation, subject to obtaining the necessary permissions and approvals from the CMB, BRSA and other relevant institutions and by meeting the requirements and conditions of the Turkish Commercial Code and Articles 19 and 20 of the Corporate Tax Law regarding the partial spin-off and other relevant financial legislation provisions. Within this scope, the assets of QNB Bank amounting to TRY 156,926,631 thousand and liabilities of QNB Bank amounting to TRY 156,926,631 thousand, which are included in the balance sheet of QNB Bank dated December 31, 2024, prepared in accordance with the banking and capital markets legislation and audited by an independent auditor, and the details of which are provided under Annex-1 of this Agreement, shall be removed from the assets and liabilities of QNB Bank at their net book (carrying) values, resulting in a zero net asset value (i.e., without any transfer of equity), and shall be transferred to Enpara Bank through partial spin-off. As the assets and liabilities set out in Annex-1 are subject to change, the values of such assets and liabilities as of the transfer date shall be taken as the basis.

4- FINANCIAL STATEMENTS WHICH WILL SERVE THE BASE FOR THE SPIN-OFF TRANSACTION

The partial spin-off transaction shall be based on the financial statements of the Parties presented in Annex-2 of this Agreement and dated December 31, 2024, prepared in accordance with the capital markets and banking regulations and certified by the independent auditing firm jointly determined by the Parties. The assets and liabilities subject to the partial spin-off shall be carried at their registered values in the statutory books of QNB Bank kept in accordance with the aforementioned regulations as of the date the partial spin-off is completed, and the relevant registration process is completed.

5- EXPERT INSTITUTION REPORT

This Partial Spin-off Agreement has been prepared and signed by taking into account the results of the valuation study set out in the report of the expert institution DRT Kurumsal Finans Danışmanlık Hizmetleri A.Ş. dated March 25, 2025, as presented in Annex-3 of this Agreement. The report of the Expert Institution has been obtained for the purpose of determining the amount of shares to be allocated to the existing shareholders of QNB Bank in the share capital of Enpara Bank in consideration of the transfer of the Enpara.com service business.

6- SHAREHOLDING STRUCTURE and MEMBERS OF THE BOARD DIRECTORS OF THE SPIN-OFF COMPANY and the ACQUIRING COMPANY

The shareholding structure of QNB Bank and Enpara Bank, the parties to the partial spin-off, is as follows. No special benefits were provided to the members of the board of directors, persons having management rights and auditors of the Parties regarding the partial spin-off transaction, except for the fee for the services provided to the expert institution.

7- PROTECTION OF SHAREHOLDERS' RIGHTS

While the assets and liabilities of Enpara.com service business shall be transferred to Enpara Bank with their book values as recorded in the financial statements of QNB Bank, the legal rights of all shareholders shall be preserved in accordance with the provisions of the Turkish Commercial Code, the Capital Markets Law, and other applicable legislation.

For this purpose, the fair value of (A) the Enpara.com service business and (B) Enpara Bank has been independently determined by an expert institution authorized by the CMB. Based on the respective values of (A) and (B), and using a ratio calculated in light thereof, shares in Enpara Bank shall be allocated free of charge by its existing shareholders to the current shareholders of QNB Bank, in proportion to their respective shareholdings in QNB Bank. The shareholders of QNB Bank entitled to receive such shares shall be those verified by the Central Registry Agency (MKK) as having the right to attend the general assembly meeting at which the Partial Spin-off Agreement is approved pursuant to Article 17 of the Regulation.

According to the report dated 25 March 2025, the details of which are presented in Annex-3 and prepared by the expert institution DRT Kurumsal Finans Danışmanlık Hizmetleri A.Ş., the fair value of the Enpara.com service business has been determined as TRY 12,361 million (A), and the fair value of Enpara Bank has been determined as TRY 9,371 million (B). Based on these values and the ratio calculated as $[(A)/(A+B)]$, it has been determined that, in consideration of the transfer of the Enpara.com service business, 56.88% of Enpara Bank's shares shall be allocated to the shareholders of QNB Bank. Furthermore, based on the current shareholding structure of QNB Bank, it has been determined that 99.88% of the aforementioned 56.88% share in Enpara Bank shall be allocated to Qatar National Bank (Q.P.S.C.), and 0.12% to the minority shareholders of QNB Bank. As a result of these determinations, following the partial spin-off, 56.81% (i.e., $56.88\% \times 99.88\%$) of the shares representing the share capital of Enpara Bank shall be held by Qatar National Bank (Q.P.S.C.), 0.07% (i.e., $56.88\% \times 0.12\%$) by QNB Bank's minority shareholders, and the remaining 43.12% shall be held by Digital Q-FS.

Although the expert report concluded that, in consideration of the transfer of the Enpara.com service business, QNB Bank's minority shareholders should be allocated a 0.07% shareholding in Enpara Bank, in order to ensure that their shareholding in Enpara Bank corresponds proportionally to their shareholding in QNB Bank, the minority shareholders of QNB Bank shall instead be allocated shares representing 0.12% of Enpara Bank's share capital.

In order to ensure that Enpara Bank maintains a strong capital structure, the controlling shareholder, Qatar National Bank (Q.P.S.C.), has remitted an amount of USD 100 million (equivalent to TRY 3,790,860,000.00 as of the exchange rate on 25 March 2025) to Enpara Bank to be added to its paid-in capital. This capital increase shall be completed without causing any change to the 0.12% shareholding that the minority shareholders will hold in Enpara Bank.

Upon the completion of the Partial Spin-off, and the capital increase referred to above, the share capital and shareholding structure of Enpara Bank shall be as set out below (calculated based on the USD/TRY exchange rate as of 25 March 2025, whereby 1 USD= 37.9086 TRY):

Regarding the Simultaneous Share Transfer Process: Separately, on 14.04.2025, Enpara Bank submitted an application to BRSA for the transfer of all Enpara Bank shares held by Digital-Q-FS Limited to Qatar National Bank (Q.P.S.C.). In the event that such share transfer gets completed prior to the partial spin-off, after the completion of the spin-off and the capital increase, the share capital and shareholding structure of Enpara Bank will be as set out below (calculated based on the USD/TRY exchange rate as of 25 March 2025, whereby 1 USD= 37.9086 TRY):

8- EXECUTION OF THE SPIN-OFF

All assets and liabilities of QNB Bank subject to partial spin-off shall be transferred to the ownership of Enpara Bank on the date of registration of the general assembly resolutions approving the partial spin-off in accordance with Article 18 of the Regulation and the partial spin-off shall be effective as of the said registration date (“**Partial Spin-off Registration Date**”).

Enpara Bank shares to be acquired by the shareholders of QNB Bank as a result of the partial spin-off shall, as of the date of registration of the partial spin-off, have the right to receive dividends.

9- AMENDMENT OF THE ARTICLES OF ASSOCIATION

Due to the partial spin-off transaction, the Articles of Association of Enpara Bank, the draft texts of which are given in Annex-4, shall be amended. QNB Bank’s Articles of Association will not be amended due to the fact that no transaction in connection with the partial spin-off would be executed that may result in a change in QNB Bank’s Articles of Association.

10- TAX LIABILITY

QNB Bank shall be responsible for the corporate income tax, Banking and Insurance Transactions Tax (BITT), Resource Utilization Support Fund (RUSF), withholding tax, and any other taxes, duties, and charges accrued in connection with the activities of the Enpara.com service business for the period up to the Partial Spin-off Registration Date, as well as those that may accrue thereafter in relation to such period. Enpara Bank shall be responsible for the corporate income tax, BITT, RUSF, withholding tax, and any other taxes, duties, and charges

arising from the assets, liabilities, and operations transferred to it through the partial spin-off as of the Partial Spin-off Registration Date.

11- CONSEQUENCES OF THE NONPERFORMANCE OF THE OBLIGATIONS

The partial spin-off and transfers shall be realized free of any collusion and the Parties shall be jointly and severally liable for any damages that may arise otherwise. QNB Bank and Enpara Bank shall take utmost care to fulfill their obligations under the Turkish Commercial Code, Capital Markets Law, Corporate Tax Law and other relevant legislation regarding the partial spin-off transaction and as set forth in this Agreement in a timely and complete manner. In the event that either Party fails to fulfill its obligations set forth in the Partial Spin-off Agreement in accordance with this Agreement and/or the law without a justifiable reason, it shall be liable to indemnify the other Party for all damages incurred by the other Party.

Following the registration of the partial spin-off, any claims and disputes that may be raised by third parties in relation to the period during which the Enpara.com service business operated under QNB Bank shall be managed and pursued by Enpara Bank. Should any matter arise in respect of such period that, upon the conclusion of legal proceedings, requires Enpara Bank to indemnify third parties, QNB Bank shall be obligated to reimburse Enpara Bank for the amounts it is required to pay. QNB Bank's indemnification obligation set forth in this article shall expire five (5) years from the date of registration of the partial spin-off. Furthermore, Enpara Bank shall be responsible for any claims, disputes, and official proceedings arising in connection with its activities following the Partial Spin-off Registration Date.

12- TRANSFER OF AGREEMENTS

All kinds of agreements, including lease agreements, concluded between QNB Bank A.Ş. and third parties regarding the assets and liabilities subject to the partial spin-off shall be automatically transferred to Enpara Bank as of the Partial Spin-off Registration Date, limited to the portion of the assets subject to the transfer. The list of agreements to be subject to transfer is attached to this Agreement (Annex-5).

13- TRANSFER OF THE PERSONNEL

The transfer of the personnel employed at QNB Bank and working in relation to the assets and affairs of the service business subject to the transfer to Enpara Bank shall be made as of the Partial Spin-off Registration Date. All wages (salary, leave, etc.), compensation (notice, seniority, etc.), personal rights of the personnel who shall be transferred to Enpara Bank through partial spin-off shall be preserved in Enpara Bank, and the personnel will not be harmed due to this spin-off.

14- LEGAL OBLIGATIONS

Pursuant to Article 8 of Annex-5 of the Communiqué, upon the completion of the partial spin-off, Enpara Bank will fall within the scope of the Capital Markets Law.

Pursuant to Article 12 of Annex-5 of the Communiqué, in the event that the general assembly meetings of the Parties regarding the completion of the partial spin-off cannot be held until December 31, 2015, this Partial Spin-off Agreement shall be deemed invalid.

The partial spin-off process subject to this Agreement is a process that requires the permission and approval of the BRSA and the CMB. It is possible to register the partial spin-off transaction in the event that the approval of the BRSA regarding the registration of the General Assembly resolutions of the Parties regarding the partial spin-off is published in the Official Gazette. In cases where there are no provisions in this Agreement, the provisions of the Corporate Tax Law, the Banking Law and the Capital Markets Law as well as the relevant legislation shall apply to the partial spin-off transaction.
