

**FOURTH SUPPLEMENT DATED 3 MARCH 2021 TO THE BASE PROSPECTUS DATED 5 MAY 2020 AS SUPPLEMENTED BY THE FIRST SUPPLEMENT THERETO DATED 14 MAY 2020, THE SECOND SUPPLEMENT THERETO DATED 27 AUGUST 2020 AND THE THIRD SUPPLEMENT THERETO DATED 17 NOVEMBER 2020**

This supplement (the "**Fourth Supplement**") is supplemental to, forms part of and must be read and construed in conjunction with the base prospectus dated 5 May 2020 as supplemented by the first supplement thereto dated 14 May 2020, the second supplement thereto dated 27 August 2020 and the third supplement thereto dated 17 November 2020 (together, the "**Base Prospectus**") prepared by DenizBank A.Ş. (the "**Issuer**") in connection with the Issuer's Euro Medium Term Note Programme (the "**Programme**") for the issuance of up to U.S.\$3,000,000,000 in aggregate principal amount of notes ("**Notes**").

Terms given a defined meaning in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Fourth Supplement.

This Fourth Supplement has been approved by the Financial Conduct Authority (the "**FCA**"), as competent authority under Regulation (EU) 2017/1129 (the "**Prospectus Regulation**") as it forms part of domestic law by virtue of the European Union (Withdrawal) Act 2018 ("**EUWA**") (the "**UK Prospectus Regulation**").

This Fourth Supplement constitutes a supplementary prospectus for the purposes of Article 23 of the UK Prospectus Regulation and, together with the Base Prospectus, comprises a base prospectus for the purposes of the UK Prospectus Regulation. The FCA only approves this Fourth Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the UK Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer or of the quality of the Notes that are the subject of the Base Prospectus. Investors should make their own assessment as to the suitability of investing in the Notes.

If you do not understand the contents of this Fourth Supplement or are unsure whether the Notes to which this Fourth Supplement relates are suitable for your individual investment objectives and circumstances, you should consult an authorised financial advisor.

The purpose of this Fourth Supplement is to: (a) incorporate by reference into the Base Prospectus the audited consolidated financial statements of the Group as of and for the year ended 31 December 2020 and the independent auditors' report thereon; and (b) amend and/or supplement certain information appearing in the Base Prospectus.

Save as disclosed in this Fourth Supplement, no significant new fact, material mistake or material inaccuracy relating to the information included in the Base Prospectus which is capable of affecting the assessment of the Notes issued under the Programme has arisen or been noted, as the case may be, since publication of the Base Prospectus.

## **AMENDMENTS OR ADDITIONS TO THE BASE PROSPECTUS**

With effect from the date of this Fourth Supplement, the information appearing in, or incorporated by reference into, the Base Prospectus shall be amended and/or supplemented in the manner described below.

### **1. Publication of the Group's YE 2020 Financial Statements**

On 2 March 2021, the Issuer published the audited consolidated financial statements of the Group as of and for the year ended 31 December 2020 (including comparative financial statements as of and for the year ended 31 December 2019) and the notes thereto, prepared in accordance with BRSA Reporting Standards, together with the independent auditors' report thereon (the "**YE 2020 Financial Statements**").

A copy of the YE 2020 Financial Statements has been filed with the FCA. The YE 2020 Financial Statements are incorporated by reference in, and form part of, this Fourth Supplement in their entirety and, by virtue of this Fourth Supplement, form part of the Base Prospectus.

### **2. Amendments to the Base Prospectus**

- 2.1 The following paragraph shall be deemed to be added as new paragraph (a) on page 54 of the Base Prospectus (and the numbering of the subsequent paragraphs shall be deemed to be amended accordingly):

"(a) the convenience translation into English of the audited consolidated financial statements of the Group as of and for the year ended 31 December 2020 (including comparative financial statements as of and for the year ended 31 December 2019) and the notes thereto, prepared in accordance with BRSA Reporting Standards (including Deloitte's audit report dated 18 February 2021 issued in respect thereof), published at:

- 2.2 The paragraph under the heading "*Significant or Material Change*" on page 231 of the Base Prospectus shall be deemed to be deleted and replaced with the following:

"Save as disclosed in "*Description of the Issuer – Recent Developments*": (i) there has been no significant change in the financial performance or financial position of the

Group since 31 December 2020; and (ii) there has been no material adverse change in the prospects of the Group since 31 December 2020."
