10. Additional information^{xvi}:

This notification is made in accordance with articles 8(1), 9(e), 12a(2) and 12(1)(b) of the Luxembourg law of 11 January 2008 on transparency requirements for issuers (the Transparency Law) in relation to (i) the acquisition of 1,108,164 class A shares by Diet Holdings, LLC (formerly known as Bistro MD Holdings, LLC) on 25 July 2025 and settled on 29 July 2025 pursuant to a share purchase agreement; (ii) the acquisition of 58,188 class A shares by AUA Health Partners, LLC; and (iii) the acquisition of 36,000 class A shares by Andrew Unanue directly. The holdings of Class A Warrants referred under section B.2. above remain unchanged compared to the previous notification dated 14 February 2024. These financial instruments have been included in this notification pursuant to article 12(1)(b) to accurately display the aggregate number of the relevant holdings. The percentages of voting rights have been rounded automatically by the eRIIS system of the CSSF, calculation may therefore display a discrepancy when manually added without consideration to rounding.

- in the circumstances foreseen in letter (d) of Article 9 of that Law, the natural person or legal entity who has a life interest in shares if that person or entity is entitled to exercise the voting rights attached to the shares and the natural person or legal entity who is disposing of the voting rights when the life interest is created;*
- in the circumstances foreseen in letter (e) of Article 9 of that Law, the controlling natural person or legal entity and, provided it has a notification duty at an individual level under Article 8, under letters (a) to (d) of Article 9 of that Law or under a combination of any of those situations, the controlled undertaking;*
- in the circumstances foreseen in letter (f) of Article 9 of that Law, the deposit taker of the shares, if he can exercise the voting rights attached to the shares deposited with him at his discretion, and the depositor of the shares allowing the deposit taker to exercise the voting rights at his discretion;*
- in the circumstances foreseen in letter (g) of Article 9 of that Law, the natural person or legal entity that controls the voting rights;*
- in the circumstances foreseen in letter (h) of Article 9 of that Law, the proxy holder, if he can exercise the voting rights at his discretion, and the shareholder who has given his proxy to the proxy holder allowing the latter to exercise the voting rights at his discretion (e.g. management companies).*

In case of multiple chains through which the voting rights and/or financial instruments are effectively held the chains have to be presented chain by chain leaving a row free between different chains (e.g.: A, B, C, free row, A, B, D, free row, A, E, F etc.). Numbers shall be attributed to all persons or entities within the group in column 1 in order to allow a clear indication of the control structure in column 6. The names of all undertakings of the control chain shall be provided in column 2, even if the number of the directly held voting rights and/or financial instruments is not equal or higher than the notifiable threshold. Columns 3 & 4 shall indicate the holdings of those persons or entities directly holding the voting rights and/or financial instruments if the holding is equal or higher than the notifiable threshold.*
